Julie serves on the Engineering Dean's Council at Texas Tech University and the board of directors of the Georgia O'Keeffe Museum. She was a director of the Federal Reserve Bank of Dallas, American Electronics Association and AIM Global board of directors.

Julie holds a B.S. degree in Chemical Engineering from Texas Tech University and is a graduate of Stanford University's Executive Program in Strategy and Organization.
